Tidy Fenland – Green Dog Walkers

During February, we have been visiting all our open spaces as part of our dog patrols. We have been socially distancing when talking to dog walkers and are pleased to report that those we ask have bags on them. We have also been supporting our Green Dog Walking volunteers and have provided them with more bags for the Manor dispenser which is being well used.

Since the lock down we have seen an increase in the amount of dog walkers out and about and any fouling's reported to us or seen on our patrols is removed.

Tidy Fenland – Fly Tipping

Figures for February are not yet completed so these will be included in next month's report.

From the figures available, we can advise that 5 fly tipped sites were attended in Whittlesey to look for evidence. Evidence was found at 1 site which was a large amount of household waste dumped in the dyke at Glassmoor Bank. We are in the process of working with a local farmer to take a witness statement as to what he found and hope that we can follow the trail left behind.

Our colleagues at Whittlesey drainage board have already moved the waste out of the dyke for us to remove more easily from the bank.

Abandoned vehicles

During February, we investigated 4 abandoned vehicles. All were removed by persons unknown once a Notice was served.

We also helped to remove another nuisance vehicle from Station Road Car park.

Street Scene Actions

- 4 graves have been marked in Whittlesey cemetery
- Trade waste monitoring has taken place at Bruce's Court following concern a local business has been using the residents flat bulk bins to dispose of their trade waste
- A takeaway business has been issued with a warning letter following reports from the pubic that staff stand outside smoking and then throwing their discarded butts into the highway
- An additional visit has been carried out at Snowley park to ensure the play area is not too busy. We have also spoken to the users about parking and the need to keep residents' driveways clear. Any cars found parked in such a manor have had nuisance vehicle notice leaflets stuck under their windscreen wipers. A new sign has also been put up in the entrance.
- A den discovered in Pinewood Avenue has been dismantled

COVID-19 Monitoring

We have ensured that all COVID-19 related signage has been refreshed in the town as well as ensuring the hand sanitiser is topped up. This is being well used which is nice to see. We are also doing compliance patrols and pleased to report no major issues or concerns.

With regard to the cases closed in the month:

- 7 cases were closed as following the investigation is was concluded that no breach of planning control had actually of taken place
- 4 cases were closed as the owner / occupier had taken the necessary action voluntarily to remedy the breach of planning control that had taken place
- 2 cases were closed as a retrospective planning application was submitted and this went on to be approved.

Open Spaces

With a much-reduced staff over the winter period, Tivoli's task is less involved with no grass cutting but the team have been active in tidying up shrubs and hedges, clearing cemeteries and adding gravel to paths and plots. The adverse weather has interrupted the flow somewhat at times, particularly with the impact of excess water but, with few exceptions, all routine tasks have been carried out on time.

Tivoli staffing, reduced over the winter period, is restored to full capacity in March and the new cutting season commenced on March 1st. Caution regarding the saturation of some areas may affect the initial couple of weeks but the first week has gone well with the new staff performing to a high standard. The departure of the main mower position for the town leaves a void and the new employee will take a while to be familiar with all areas but will be given all required support to settle in.

Play areas remain open, despite the COVID-19 restrictions, although closure will take place quickly if circumstances change. Inspections have continued to take place weekly throughout the pandemic.

The play area extension at Snowley Park continues to be busy and successful. Public reaction has been excellent albeit there is some resident concern about the increased volume of traffic. Signage is now in place to ask visitors, some of whom come from Ramsey and March, to park responsibly. Three benches and an extra bin are on order.

New plants have been planted in the tubs on Buttercross.

In the town, the following took or is taking place:

- Additional gravel for kerb sets and pathways at cemetery
- Ramp to north of Snowley Park play area installed
- New trees pinned in cemetery
- Wildflower bed trimmed Claygate
- Station Road Play area surface replaced and reopened
- Hedge work 100% complete
- Shrub clearance Snowley Park
- New bins at cemetery
