As usual 'someone' asked me for a comment on yesterdays FDC motion on Councillors Allowances - I don't know if any other Councillors are asked this question – I doubt it.

Firstly I will comment on yesterday's FDC meeting. Having read **ALL** the paperwork that the Independent Pay Review Group had supplied.

I believe that in FDC's case it was a fair and well-presented case and since there had been no increases in 'allowances' since 2019 I have no issue with this. Less than 3% increase.

Remember 'I/we' Town Councillors receive NO allowances or expenses.

Now I will comment on County Council (Cambridgeshire) – The 'new' Rainbow Alliance (Labour/LibDem & Independents) have stated they will 'save' some £72,000 of the total bill because of some Committee changes. It remains to be seen whether their 'normal' allowances will remain the same.

Of course what has not been factored is the retirement of Chief Exec – Gillian Beasley. Cambs CC & Peterborough have decided not to share this post – So – Bang goes the £72,000 and the rest it will cost.

Below I am happy to post my comments on now ex leader Cllr Steve Count (Conservative) approach to allowances when he was re-elected as Leader in the previous administration.

lower.But following a vote at a full council meeting (July 18th 2017) a **30%** increase to £10,315 was agreed, bringing it in line with the national average for two-tier authorities.

A number of special responsibility allowances were also substantially increased, **in excess** of the recommendations by the council's Independent Remuneration Panel (IRP), but also in line with the national average.
