ED: introduced financial advisor for pensions.

## F186/2025- Presentations.

### Getting Britain Back to Work

HN: local version of national program.

Get Cambs & Peterborough back to work.

Primarily to do with sickness – Economically inactive people.

Fenland is at bottom of index of multiple deprivation & NEET (Not in employment, education or training)

### Amanda Wood – Asst Director for Skills & Employment CPCA

Plan written in partnership with NHS & jobcentres.

Local version of white paper from Government – work towards 80% employment across region.

Also, how services are tackling inequalities and work together.

Cornerstone of Local Growth Plan. 0-year plan.

Rising inactivity, mainly through student population.

Fenland 25% inactive.

Plan approved at board 2 weeks ago. Publish after Christmas.

C&P one of 8 areas in 'Youth Guarantee'.

AM: Great advocate of apprenticeships. Not taken up by CPCA.

BW: Peterborough College remove assisted transport. Key thing in rural area.

BNW: Transport to work & college needs big bucket of money.

CB: Fenland in a very poor place for education & training. Comparison of 296 local authorities. Fenland came bottom in education, skills & training. South Cambs almost at top of list! Local skills improvement plan coming up. £12m adult skills fund. Historically spent in a way that is biased against Fenland. Transportation is a huge problem. Have made request that transportation in Adult Skills Fund. Not historically part of it, but a fundamental block.

Response: Last academic year, 986 adults (in Fenland?) able to access funding. Should be a policy in place to support transport.

ED: 3 Problems – Employer reluctance if not very good. 'Work Experience' – lasted 3 weeks at a time. Allowed employer to 'trail' employees. CV enhancement. Had better transport. Should not be up to employer to provide transport.

Response: WE critical part of journey back to work. Government putting in requirement for 2 weeks for all. CPCA operate regional skills hub to schools. Measure quality of careers advice.

PB: Discussion moved from everybody to young people – secondary school is failing, transport is atrocious – what about bringing trainers to the schools? Raises aspirations, raises expectations in the schools, raises awareness of fenland potential.

AM: Bringing employers into area to discuss with schools – why not in Whittlesey?

Response: Is a requirement, should be happening. Many schools in rural communities struggle to get engagement. Can check on what the situation is in Whittlesey. CCC also have a responsibility for NEET.

BW: Used to be a scheme called Trident work experience – employment taster – gone. Transport to secondary health care – no Whittlesey transport to Kings Lynn.

DD: Agree make use of local teachers? Fenland is agricultural – should design course for local needs, not just general.

HN: Whittlesey 'Cinderella' town. Fenland Cinderella region. Now understand the deprivation index. This is a real opportunity to make a difference.

**F187/2025** Presentation from CCC: Ralph Butcher Causeway

No representative from CCC

CB: Head of complex infrastructure will look to confirm attendance on 22/01/2026

78 weeks since traffic lights put up.

June 2025 told work starting 8/7 for 22 weeks. Schedule was for 20 weeks, but +2 allowance.

They have put out release every 2 weeks.

3 weeks before end, state end of January.

December & January worst months for closure of North Bank/B1040.

Have pushed for alternatives, including removing restrictions. Also said that alternative routes will be examined to ensure they are in a fit state to take the traffic. Response today – remedial work identified on Milk & Water Drove. B1095 an order being placed for patching work early January (night work).

B1040 an order being placed for patching works. Will be after M&W Drove?

CB: Using written question at next meeting.

BNW: FOI statement disclosed

CB: Asks for copy also Michael Fisher

ED: Many people concerned about when bridge is accepted, who is liable if problems recur? Will it be insurable.

CB: Problems emerged during snagging period. MF looking at contract termination date – plan is to hand over on 31/03/2026

Followed by agenda Item for Discussion - **Ralph Butcher Causeway - Barry W**

BNW shared the content of an FOI request he submitted on the bridge project.

He asked five specific questions: When did CCC first become aware of the latest slippage to program (30/10/2025);

How long was the delay before the public were informed (12 days from formal notification on 3/11/2025);

Was there a process in place to examine the progress reports from the contractor and determine their accuracy or were they simply taken at face value? (process of weekly meetings with Jones Bros and "regular site visits").

Was the contractor asked for confirmation of the end date at any time, and did they confirm the 8th of December date, or admit to some slippage in the programme? (Program discussed each week at progress meetings, slip declared formally on 3<sup>rd</sup> November).

Is there a plan for a review of the Project Management of this contract by CCC, given the adverse effect on Whittlesey and the A605 transport route? (There is no formal review planned).

The latter statement that no formal plan was to be carried out raised some surprise and discussion. Cllr. Boden asked for a copy of the FOI response to be sent to him and Cllr Fisher, as the written responses contradicted some of the information they had been given.

**F188/2025. Street Scene Officer Report & CCTV update**

ED: Noted the statements concerning Provision of Dog Fouling materials and questioned what and where these were. BNW answered that he has received a stock of 60 'No Fouling' street notices and has been putting them up around the area.

**Peter Baxter:** Listed Building act planning committee has legal duty to preserve conservation areas & listed buildings. How did council apply their responsibility.

**SO (Standing orders) suspended.**

*AM responded that Chair of planning had no authority to change status.*

*PB Has been told on many occasions what the situation is*

*Disrespectful to council & AM personally*

*PB: believe that is wrong.*

AM: Chair of committee only has responsibility to consider planning meetings

**SO, Resumed**

**Robert Windle:** Extravaganza on Saturday. Expanded to 9 rides.

Need volunteers. Thanks to SA for help with this & other events.

Advanced sales going well – 200 sold.

Wally Newman – Endorse nomination to Freedom.

**Mark Cross:** Contacted Jones Bros last year. In 2003 Starr Knothole was dry. Large fissures in walls of knot hole. Water was entering fissures and softening clay. Will never be fixed. Fissures at least 70' deep.

On Jobs there are no apprenticeships for young people. A605 drains in Eastrea Dip haven't been cleaned. Also, alongside Saxon Pit

**Julie Windle:** Echo support for Wally Newman.

**F192/2025** Agenda items for Discussion.

To reinstate a property/premises group for Peel House buildings.

(previous members Cllrs David Mason, Alex Miscandlon & Eamonn Dorling) - DL

CB: DL's suggestion is to reconstitute a working group – suggest it be passed to next F&P – agreed.

Local Highway Improvements (LHI) WTC submission on or before January 2026.- DL and Barry W.  
ED: MVASS data does not support speeding.

CB: Not the average that matters – it's the numbers that exceed. Exceptions are noticed. Massive change in Teal Road with the opening of Hartley Grange. Needs to be a physical way to stop the speeders. Only possible to put in traffic calming on skater street.

BW: On double yellows – enforcement. BNW: not compliant

CB: Needs civil enforcement. Have £400k towards work necessary to correct signage & markings.  
Last estimate is £900k

HN: Double yellows only useful with enforcement. Chicane on Teal Road.

BW: Propose Teal Road. Sec HN. Passed 7x1

BNW: Will the council consider funding additional yellow lines. – can be considered at a future date

**Citizen's advice.**

CB: Costs increasing from £6,800 to £7,980 and want a 3-year agreement.

Accept charges but delay SLA

CB/BNW – unanimous.


I am **Roy Gerstner** the only Councillor in Whittlesey who makes regular reports on Council, Public and Community Group meetings.
